This illegal trade often evades taxes or involves substantial under-invoicing. Additionally, taking dollars out of the country through airports remains relatively easy. The article highlights the widespread availability of smuggled foreign goods in Pakistan, as a nexus between traders and customs officials contributes to this problem. To combat smuggling effectively, it is crucial to make it challenging for traders to display and sell such illicit goods while dismantling the connections between traders and officials posted along borders and ports. Smuggling continues to harm the economy, weaken industries, and impact employment and public welfare. It is



hoped that the ongoing efforts against illegal cross-border trade will not be prematurely terminated, as has occurred in the past.
